THE MERGER In February 2012, Domme Facilities Management Limited, then one of Nigeria's leading Facilities Management Companies, merged with WSP-FMC Nigeria Limited to strengthen the company's capability in the local Nigerian market.

NAME CHANGE In 2014, the shareholders of the company decided to change the company's name after the exit of WSP to Global **Properties &** Facilities International Limited, the company is expected to operate in Nigeria and West Africa.



CHANGE IN SHAREHOLDING At the beginning 2018, Capital Alliance divested her shareholding from Global PFI paving way for Domme FM Ltd to acquire controlling shares in the company making it the majority shareholder. The board of the company was restructured with Directors representing Capital Alliance leaving and new Directors representing Domme FM Ltd coming on board.
